Beyond trade in technical committees, a decision of this importance should be discussed and decided in the meeting of ministers, that is to say politically.-----THE CONTEXT-----

Following the Volkswagen case, the Minister of Ecology and Energy, Segolene Royal promised a series of tests over a hundred diesel vehicles to detect possible fraud to pollution. This decision was taken by the Minister, the latter week following the Volkswagen scandal, while about 1.1 million vehicles could be affected in France.-----

"This is a premiere in the world. This is the first time a country, a Ministry of Ecology, Sustainable Development and Energy (...) establishes a scientific system of control to identify whether there are fraudulent equipment on a vehicle," said Segolene Royal, on a visit to the testing center testing center technical Union of automobile, motorcycle and cycle (UTAC) Linas-Monthlery (Suburb of Paris) where tests are conducted.-----
